

## Application for the Fall 2026 RACC Study Program

### ABOUT THE RACC STUDY PROGRAM

The RACC Study Program at Emory University is a guided, self-study program designed to assist research administrators in preparing for the Certified Research Administrator (CRA), Certified Pre-Award Research Administrator (CPRA), or Certified Financial Research Administration (CFRA) exams offered by the Research Administrators Certification Council (RACC). The program introduces exam requirements, key dates and resources, a comprehensive body of knowledge, sample questions, and insights from past exam takers. Designed to support examination preparation, participation in the study program does not guarantee a passing examination score.

During the Program, participants will meet via Zoom every Monday for 1.25 hours from August 10 to October 19, 2026, 3:00 to 4:15 PM ET. Participants will receive 1.25 contact hours for every session attended toward the ORA Continuing Education requirement.

### ABOUT RACC EXAMINATIONS

The Research Administrators Certification Council ([RACC](#)) offers the CRA examination three times a year and the CPRA and CFRA examinations twice yearly. Each exam covers various research administration topics, including governing framework and sponsor interface, project costs, and compliance considerations. The CRA covers the lifecycle of research administration, including general office management and contracted services, whereas the CPRA and CFRA exams dive deeper into pre- and post-award topics.

Applicants take the exam at a designated site administered through the Professional Testing Corporation (PTC). Each state has multiple test sites. Examination applicants select a test site and date within a testing window. Registration deadlines and exam dates vary by exam type and can be found on the [RACC webpage](#).

### RACC STUDY PROGRAM REQUIREMENTS

- Individuals interested in participating in the RACC Study Program must submit the completed application form on page 2 to [tricia.callahan@emory.edu](mailto:tricia.callahan@emory.edu) by 12:00 PM ET on 07/31/26.
- Applicants must have supervisor approval to participate.
- Applicants should be eligible for the Fall 2026 RACC exam. Exam eligibility requirements include:
  - A bachelor's or advanced degree and three (3) years of professional experience in research administration (pre-award experience for the CPRA, post-award experience for the CFRA) or sponsored programs administration in a sponsoring or recipient organization or the equivalent in a self-funded organization, -OR-
  - An associate degree and five (5) years of professional experience in research administration (pre-award experience for the CPRA, post-award experience for the CFRA) or sponsored programs administration in a sponsoring or recipient organization or the equivalent in a self-funded organization, -OR-
  - No degree and six (6) years of professional experience in research administration (pre-award experience for the CPRA, post-award experience for the CFRA) or sponsored programs administration in a sponsoring or recipient organization or the equivalent in a self-funded organization.
